#### **Consultation lesson**

The Music School administration will send you an invitation for your consultation lesson by a teacher with your desired instrument or course. The enclosed flyer "consultation lesson" will inform you of the content and purpose of the consultation lesson itself. The consultation lesson costs Fr 50.-. This amount will be charged with your first school fees. Non-entry will be charged separately. Further consultation lessons can be booked if required. (see following page as well)

#### **Definitive application**

The definitive registration is with the application form. You can find it on www.schule-zumikon.ch or request it at the Music School. You can apply anytime but the **application deadlines** for the following semesters are: **31st of May** and **30th November**.

### Rights and responsibili

- a. It is the music school and tariff regulations.
- b. The music students are entitled to qualified and regular music lessons.
- c The final registration is binding. It undertakes regular visits to the classroom as well as for the regular preparation at home.
- d. Without termination, the application will consist of the following semester. An exit is at the end of a term spent by written notice to the school administration to **31st May** and **30th November**.

# Information about Music School Consultation lessons

The first concern of the music school Zumikon is to convey their music students and music students joy, success and self-confidence in making music. Experience has shown that the expectations of the music and the music lessons are great. This requires a careful assessment of the needs of all parties, children, parents and teachers. The consultation lesson is to help prevent failures and to enable success.

Therefore, a proper evaluation and advice in a consultation lesson is mandatory and a prerequisite for admission to private lessons at the music school Zumikon.

#### The consultation lessons include:

- a. Brief introduction to the fundamentals of the game of the instrument and his own first attempts
- b. aptitude test for the selected instrument (physical / motor conditions), advice on the choice of instruments / rental
- c. clarification of any musical knowledge (prior music lessons, hearing, rhythm, notation skills)
- d. clarify the motivation of the child for music lessons, mutual expectations of child / parent / teacher, as well as the temporal scope for practicing and hour division
- e. conversation, the ease with which experience has shown what progress is possible as well as the nature and scope of the most necessary support at home
- d. focus on teacher allocation by the music school management, the tuition, the schedule assignment / instruction days, compliance with the registration and cancellation of the existing compulsory education (regularly attending classes and practice) and general reference to the school rules.

#### **Allocation**

The Zumikon Music School shall communicate to interested parents and children for counseling lesson wherever possible to a teacher who has spare capacity in the following semester.

# **Duration / costs**

A consultation lesson lasts 40 minutes and costs CHF 50 -. This amount will be charged separately to the first tuition bill or after no entry. If necessary, several counseling lessons can be booked.

#### Fees

- Actual fees/Musikschulordnung, holidays and free of school days are published on www.schule-zumikon.ch/musikschule
- b. Zumikon residents and non residents pay the very attractive tarif level 21.
- c. Zumikon residents who want to pay less (level 1-20) accept that the Zumikon tax office makes the classification based on their tax documents.
- d. You have more than one child in the Zumikon music school? You have a fee-reduction for this reason. (Geschwisterrabatt)

# Application of schedule for ICS:

ICS students miss some lessons during the semester because of different holiday schedules of both schools.

To compensate them we applicate the tarif structure as following:

- a. The ICS-student pays the tarif which is applicable.
- The music teacher teaches 5 Minutes longer every lesson. (35 min. instead of 30 min., 45 min. instead of 40 min.)
- c. So all missings are exactly compensated. (this result is based on an exact analysis.)
